MOTION #12/03/14 – Moved by Member Bednard and supported by Member Pyden that the Board of Education conducted a hearing on December 1, 2014 in a closed session concerning the Administrations' recommended expulsion of Student 12/01/14:MHS02.

The Student and the Student's parents had been advised on the charges against the student in writing, and had been advised of their due process rights. The Student was provided with all due process rights required by law and District policy.

The Board has considered all of the evidence presented at the hearing and based on the evidence has reached the following conclusion: Student 12/01/14:MHS02 was guilty of Sections IV.9, "Physically assaulting a staff member/student/person associated with the District."

Therefore, it is resolved that Student 12/01/14:MHS02 be permanently expelled from the Chippewa Valley School District. Student 12/01/14:MHS02 is prohibited from entering any premises owned, operated or controlled by the District or attending any District function. Ayes, all. Motion carried.
