**MEMORANDUM**

**G.1 Approve Resolution to Participate in the Macomb Oakland Aggregate Bus Fuel Purchasing Program and Award Bid to Spencer Oil for 2012/2013 Mr. Sederlund**

RECOMMENDED MOTION: “That the Chippewa Valley Schools Board of Education approve an annual resolution to authorize participation in the Macomb Oakland Aggregate Bus Fuel Purchasing Program for the 2012/2013 school year, that the reading of the resolution be waived, and that the award for purchase of bus fuel for 2012/2013 be to Spencer Oil.”

RATIONALE: The District has participated in the bus fuel purchasing program since its inception in the 2003/2004 school year. Aggregating fuel volume of many districts into one (1) bid secures competitive pricing for participating districts. The latest bid was awarded during the July 18, 2011 board meeting and allows for two (2) annual contract extensions.
