THEREFORE, it is resolved that Student <u>02/05/18:ALG01</u>, be permanently expelled from the Chippewa <u>Valley School District</u>. Student, <u>02/05/18:ALG01</u>, is prohibited from entering any premises owned, operated or controlled by the District or attending any District function.
