Superintendent Roberts reported on the following:

- Board members received a red folder for the Chippewa Valley Schools 2019 Red Ribbon Campaign sponsored by the CV Coalition for Youth & Families on behalf of October being "Red Ribbon Month", a national celebration to promote a drug-free America. The Coalition works to support Chippewa Valley School's on-going drug prevention efforts.

- Congratulations to Mr. Walt Kozlowski (Exec. Dir., Innovation & Learning) and family on the birth of his fifth child, a boy.
