THEREFORE, it is resolved that Student 10/14/19:CVHS03, is expelled from the Chippewa Valley School District, from October 14, 2019, through the conclusion of this semester (January 24, 2020). Additionally, at the time of a request for reinstatement at the semester is made, if reinstatement is granted, it shall be pursuant to a last chance agreement. Student, 10/14/19:CVHS03 is prohibited from entering any premises owned, operated or controlled by the District or attending any District function for the duration of the expulsion.

Upon such time that 10/14/19:CVHS01 applies for reinstatement to Chippewa Valley Schools, any possible reinstatement shall be made pursuant to a last chance agreement.
