H.1 Approve Revision to By-Law #0142/Election of Board Members (first reading) Mr. Sobah

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education approve a revision to By-Law #0142/Election of Board Members as mandated by State of Michigan legislation."

RATIONALE: The current cycle of elections for members of the Board of Education is odd year May with six (6) year terms. With the passing of House Bill 4005, Michigan election law was amended to require all school board elections be held in November of even regular election years with six (6) year terms. This is effective for November 2012 and will extend current board member terms accordingly.

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education by resolution indicate its support of the Macomb Intermediate School District proposed budget and the reading of the resolution be waived."
