G.2 Approve Resolution to Amend the 457 Plan Document Mr. Sederlund

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education approve the Chippewa Valley Schools 457 Plan Document Amendment, authorize the Assistant Superintendent of Business and Operations to execute the amendment, and waive the reading of the amendment."

RATIONALE: A 457 program allows for eligible employees to contribute funds on a tax deferred basis through payroll deduction to multiple annuity and investment companies until the money is withdrawn from the program which normally occurs after retirement. The 457 Plan needs to be amended based upon certain changes made to the IRC that affect these plans, including the Pension Protection Act of 2006, the Heroes Earnings Assistance and Relief Tax Act of 2008, and the Worker, Retiree and Employer Recovery Act of 2008.

The Plan Amendment has been reviewed and prepared by legal counsel.
