Therefore, it is resolved that Student 01/23/12:DAK04 is permanently expelled from the Chippewa Valley Schools District. Student 01/23/12:DAK04 is prohibited from entering any premises owned, operated or controlled by the District or attending any District function. Ayes, all. Motion carried.
