SCHOOL DRIVING AND PARKING REGULATIONS

- 1. All motor vehicles on school grounds must be registered with the school and must display a current parking permit on rear view mirror with the numbers facing outward. Please register <u>all</u> vehicles in the household that may be driven to school.
- 2. If your parking permit is lost or stolen report it immediately to the office. AFTER A WAITING PERIOD, a new parking permit may be available at the replacement cost of \$10.00.
- 3. Students may not loiter in their cars at any time. Students may not go to their cars during school time without written permission from a school administrator. Students <u>must</u> park in their designated lot. Students <u>are not</u> allowed to park in any staff lot. Violation of these regulations may result in revocation of parking privileges.
- 4. Student's vehicles may be subject to search if there is "reasonable suspicion" to suspect drugs, tobacco, alcohol, weapons, stolen property or other contraband that may be present in the vehicle.
- 5. The Clinton Township Ordinance (no parking ordinance) and the school parking regulations, parking within the lines, observing a 5 MPH speed limit, cooperate with security guard(s), safe and courteous driving at all times and observing posted signs, will be strictly enforced. Suspension or total loss of driving privileges, ticketing or towing of vehicles and/or suspension from school may result when violation of these regulations occur.
- 6. Students who find it necessary to leave school early, in case of an emergency, must have an "Early Dismissal Pass" from the Attendance Office to leave any lot before their assigned time. ETA, CO-OP and Dual Enrollment students must provide proper identification of their enrollment in the class and show it to the security guard upon departure.
- 7. Leaving Campus for lunch is strictly forbidden. Permanent loss of parking privileges may result.
- 8. Students park at their own risk. The school will not be responsible for vandalism, damage, or theft. For your protection doors and windows MUST be locked while vehicle is on school property.
- 9. If a student's attendance is affected with either excessive absences or tardies in their first hour class, because of driving to school, their parking permit may either be suspended or revoked.
- 10. All school and library fees and fines must be PAID IN FULL before a parking permit can be purchased.

- 12. Students who transport any students who are truant or violate the school code of conduct can lose driving privileges.
