2023-24 DAKOTA HIGH SCHOOL DRIVING AND PARKING REGULATIONS


- 1. All motor vehicles on school grounds must be registered with the school and must display a current parking permit on the rear-view mirror with the number facing out. Students that fail to purchase a parking tag are subject to school discipline, including having their vehicles towed at their expense.
- 2. Students who have not purchased a personalized parking spot that make the poor choice to park in another student's personalized spot can be subject to disciplinary action, may have their vehicle towed, and/or may have their parking privileges revoked.
- 3. If a student's parking permit is lost or stolen, they must report it immediately to the office. Students may purchase a replacement parking tag for \$10. If the lost tag is recovered, a reimbursement will be issued with the return of the newest tag.
- 4. Students may not go to their cars during school time without written permission from a school administrator. Violation of this regulation may mean school discipline and/or revocation of parking privileges.
- 5. Students' vehicles may be subject to search if there is "reasonable suspicion" to suspect drugs, tobacco, alcohol, weapons, stolen property or other contraband that may be present in the vehicle that violates the Student Code of Conduct. Tobacco and vape products are a violation of the Student Code of Conduct even if the owner of the vehicle is over the age of 18, and thus subject the student to disciplinary action and possible revocation of parking privileges. Per the Student Code of Conduct, all searches may be conducted with or without a student's consent, and if given a reasonable direction by a staff member, the student is expected to comply. Non-compliance with such directions, including a direction given by a staff member to open a vehicle for a "reasonable suspicion" search, can result in disciplinary action and possible revocation of parking privileges.
- 6. Macomb Township Ordinance #18 (no parking ordinance) and the school parking regulations, parking within the lines, observing a 5 MPH speed limit, cooperating with security guard(s), safe and courteous driving at all times and observing posted signs will be strictly enforced. Suspension or total loss of driving privileges, ticketing by the police, or towing of vehicles and/or suspension from school may result if violation of these regulations occur.
- 7. Students who have permission from a parent to leave school early must have an "Early Dismissal Pass" from the Attendance Office to leave before dismissal time. Students enrolled in the Early College, Careers in Education, Internship, Dual Enrollment, Medical Academy English 12, 21F online learning or other similar programs must provide proper identification of their enrollment in such programs and show it to the security guard upon departure.
- 8. Leaving campus for lunch or other reasons without parent permission and an early dismissal pass is strictly forbidden. School discipline and permanent loss of parking privileges may result.
- 9. Students park at their own risk. The school will not be responsible for vandalism, damage, or theft. For students' protection, doors and windows MUST be locked while vehicle in on school property.
- 10. If a student begins to accumulate excessive absences or tardies in their first hour class because of driving to school, their parking permit may either be suspended or revoked.

11. SHARING OR SELLING OF TAGS TO OTHERS MAY RESULT IN SCHOOL DISCIPLINE AND/OR LOSS OF PRIVILEGES – NO REFUNDS!

- 12. Students who transport any students who are truant or violate the school code of conduct can face discipline and/or lose driving privileges.
- 13. The district provides transportation between DHS and Chippewa Valley High School for specific programs and classes schools during the school day, therefore students are prohibited from driving a vehicle between high schools unless permission is granted by a building administrator or designee.

It is understood that a violation of any of the driving and parking regulations may result in the suspension or loss of this privilege.

There will be no student drop-offs in the morning or pick-ups at dismissal from the bus lot. This area is reserved for busses only. Parking is not permitted in this area at any time during the school day including pick-up and drop-off time. The north doors will be closed and locked during the school day. All student drop-off & pick-up and visitor parking will be on east drive/main entrance side of the building.
